Station staff to strike February 5 - February 8

* 10:00 hours on Tuesday 7th February 2017 and 00:59 hours on Wednesday 8th February 2017

Since our station strike on 9th Jan management have finally agreed to look at RMT's demand to make all CSAs CSA1.

Before the action they had simply ignored the issues around CSA1/2.

We have also had detailed discussions about overall job numbers and re-staffing control rooms.

Since the 9th we have consistently pressed LU to make a new proposal to deal with these issues but very little being put on the table. This is unacceptable. LU made the mess of Fit for the Future and they need to get on with fixing it.

Therefore the RMT NEC has called further strike action over three days starting Sunday 5 Feb. As always, your RMT negotiating team remains ready to talk (despite what LUL and the Evening Standard say) and we will continue our efforts to get LU to meet our demands.

The overtime and rest day working ban, non-familiarisation and non-rostering of overtime remains on as a clear demonstration that it is not possible to run a decent service without sufficient, experienced, safety-critical staff.

Due to legal restrictions within anti trade union laws the OT ban etc will be suspended for the duration of strike action.

Staff Our Stations Emergency Public Rally *in support of Tube workers*

Tube journeys are up by 23% in the last six years. Even Tube management have conceded that the 838 job cuts, imposed by the previous Mayor, have had a devastating impact on passenger safety.

The cuts have also left station control rooms – which are the "eyes and ears" of the network - unstaffed. This has led to a serious threat to passengers at a time of heightened safety and security alerts. Last year's incidents at Canning Town and North Grenwich, exposed just how serious those threats are. Those safety warnings have been reinforced by daily reports of intolerable overcrowding and pressures on stations and services right across all routes

With the constant overcrowding on stations and platforms, it is only a matter of time before there is a major tragedy.

RMT has confirmed a new phase of action from the 6 February, as part of Tube workers' campaign for safe staffing levels.

Fleet branch to ballot over breach of agreements

Due to a breakdown in industrial relations with management and the ongoing attacks at various levels. This branch call on the General secretary to advise LUL that we are now in dispute and instruct the

NEC TO Ballot "ALL" LUL fleet members for strike action and action short of strike.

This action has been called due to management breaching the agreed machineries, our Main agreement, and long standing local agreements, namely

Not consulting or negotiating with this in union in in relation to reducing staffing levels within fleet contrary to section 6.1.1 of the main agreement.

Breaching the night tube agreement to recruit an additional 8 staff on the central which management have reneged on.

Actively obstructing the reps from carrying out there official duties.

Failure to follow correct process when seeking roster changes.

Removing a very long and established practice of "phone in days" throughout fleet without full and meaningful consultations.

The RMT will always be open to discussion with management to try and resolve these issues. But unless we stand up and fight for our agreements both main and local we will have no agreements left with which to defend ourselves. Management will systematically rip them apart. Therefore we URGE ALL members to vote YES on strike action and action short of strike in the forth coming ballot.
